OSRBA YOUTH RABBIT and CAVY MANAGEMENT CONTESTS

PURPOSE

To acknowledge excellence of management style by OSRBA youth members in the areas of housing and equipment, feeding and animal care, disease control, record keeping, breeding and genetics for the care and production of rabbits and/or cavies and to prepare the Ohio youth for ARBA National Convention

RULES

- 1. Any OSRBA youth member is eligible to compete. Exhibitors must be members by April 1st of the current contest year. Attendance at the OSRBA convention show is not necessary.
- 2. Contestants must be a permanent resident of Ohio
- **3. Applicants may enter 1 rabbit division <u>AND</u> 1 cavy division.** Be sure to provide the appropriate application when submitting either rabbit, cavy, or both rabbit and cavy.
- 4. Management application is to be composed and completed by the contestant.
- 5. Applications will be judged based on the categories provided below:
 - a. Limited Rabbitry (1-20 holes)
 - b. Average Rabbitry (21-50 holes)
 - c. Unlimited Rabbitry (51+ holes)
 - d. Any Size Caviary
- 6. Do NOT put your name, ARBA number, or any other headings on your application.
- 7. The two most popular, and readable, fonts are Times New Roman and Arial, using 10 or 12 point types. Applications MUST be provided as a PDF
- 8. Applications must be <u>no more than</u> 7 pages in length, single-sided, with a minimum of ½ inch page margin, and must be in the words of the applicant. Contest entry form does NOT count toward 7 page maximum
- 9. Contest entry form and <u>ONE</u> copy of your answers with the questions above each answer must be provided via e-mail submission with contest entry form
- 10. A winner will be selected from each division and announced at the Sunday morning ceremony of OSRBA show weekend. Contestants do not need to be present to win but attendance is encouraged
