

Ohio State Rabbit Breeders Assoc., Inc.
Show Agreement
SPECIALTY SHOW



This agreement entered into, on _____(date) by and between the Ohio State Rabbit Breeders Association, Inc. (OSRBA, Inc.) and _____ (club name) _____(acronym) to host the Single or double (circle one) specialty show on _____(date(s)) at the Ohio Exposition Center O'Neill building or/and Voinovich building in conjunction with the Ohio State Rabbit Breeders Association's annual Mini Convention held in Columbus, OH. The building is subject to change without notice.

Whereas the parties herein desire to set forth their respective responsibilities as they relate to said show: Now therefor, and in consideration of the mutual premise of the parties herein it is agreed as follows:

1. _____(acronym) shall pay a show exhibiting fee per animal entered in the amount of \$3.75 per animal entered. A copy of the rabbits entered must be submitted at the OSRBA show office with final payment by Saturday at 6:00 PM, when the office closes. If payment is not made by the designated time, then the deposit is also nonrefundable. Copies of the show entry form can be copied at the show office free of charge. *All specialty show contracts must be in by **February 1** with a \$35 deposit to have an advertisement in the OSRBA, Inc. printed show catalog. Late specialty show contracts will be accepted until March 25 with a \$50 deposit.* The \$35 or \$50 deposit is nonrefundable if a representative is not there to help set-up or tear-down. ***No shows will be held without a signed contract.*** *Checks must be made payable to Ohio State Rabbit Breeders Association Inc.*
2. The payment for said fees shall include the following:
 - a. Buildings and facilities at the Ohio Expo Center. O'Neill and/or Voinovich buildings.
 - b. Security for the building.
 - c. General liability insurance.
 - d. Clean up before, during, and after the show.
 - e. Consulting service as required.
 - f. Scales and judging tables.
3. It shall be the responsibility of the _____(acronym) to provide the following:
 - a. Hosting the show with club personnel
 - b. One Representative from Club to help with set up
 - c. Show supplies.
 - d. Show Catalog.
 - e. ARBA and specialty breed sanctions.
 - f. Airport and other transportation of exhibitors and animals.
 - g. Awards

Additional Information:

1. Club booth cost will be provided on booth contracts. Booth space is 8'x10'. There will be one table and two chairs provided. No side drapes or table covers provided. Any drapes must be flame retardant.
2. No other animals allowed in the building other than rabbits and cavies except service dogs.
3. (acronym) hereby releases and discharges OSRBA, Inc. officers, directors, show committee, from all rights, and claims, and actions which the _____ (acronym) and its successors now have or may have after signing this agreement arising out of the contract and all other aspects as is related to National, Regional, and State Specialty Show(s).
4. Parking passes can be purchased at \$7.00 daily and \$17.00 weekend pass at the entrance gate. The fee is subject to change without notice.
5. Camping permits can be purchased at the gate with full-service electric, water, and sewage. Subject to first come first serve.
6. No animals in the showroom before Friday at **NOON**.
7. Club specialty shows (not in conjunction with a national show) can be held Saturday and Sunday but limited to one specialty a day.
8. All OSRBA, Inc. hired judges will be paid by OSRBA Inc. **Any payment to judges by the sponsoring club will not be subtracted from monies owed to OSRBA.**
9. **COOPING WILL NOT BE MADE AVAILABLE UNDER THIS CONTRACT. COOPS CAN BE RESERVED BY INDIVIDUAL EXHIBITORS BY ENTERING THE RABBIT IN AN OSRBA SPONSORED ALL BREED SHOW.**

This agreement constitutes the entire agreements of the parties and supersedes all prior understanding or written or oral agreement between parties respecting its subject matter.
