

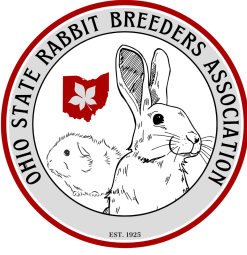
Ohio State Rabbit Breeders Association, INC. National Show Agreement This agreement entered on \_\_\_\_\_ (date) by and between the Ohio State Rabbit Breeders Association, INC (OSRBA, INC) and \_\_\_\_\_ (club name) \_\_\_\_\_ (acronym). To host a national show on \_\_\_\_\_ (date) at the Ohio Exposition Center in the O'Neill and/or Voinovich building in conjunction with the OSRBA, INC. annual mini convention in Columbus, Ohio. The building(s) and location are subject to change without notice.

Whereas the parties herein desire to set forth their respective responsibilities as they relate to said show: Now therefore and in consideration of the mutual premise of the parties herein it is agreed as follows:

1. \_\_\_\_\_ (acronym) shall pay an exhibition fee of \$3.50 per animal entered. A copy of the rabbits entered must be submitted to the OSRBA show office with the final payment by 6:00 PM of the show weekend. A \$100 deposit which will be deducted from the total amount owed of the exhibition fee (if the deadline above is met, if it is not the deposit will NOT be deducted). All signed contracts and deposits are due by January 1 of the year the national show is being held. An additional deposit of \$100 for a clean up and terms and conditions is required at the time of signing the contract (if all of the terms and conditions are met **ESPECIALLY SECTION 3 and 4** this deposit will be refunded within 30 days)

2. The payment for said fee shall include the following:

- Building and facilities
- General liability insurance
- Coops and bottom boards
- Judging tables, judging coops, and holding coops
- Set up and tear down of coops, judging tables, judging coops, and holding coops
- Initial shaving in coops (if additional shavings are needed it is the responsibility of the exhibitors and/or the club hosting the show)
- Consulting services as required

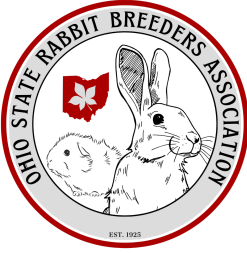


3. It shall be the responsibility of the \_\_\_\_\_ (acronym) to provide the following:

- **A MINIMUM OF ONE REPRESENTATIVE OF THE CLUB HOSTING THE SHOW MUST BE PRESENT AT SETUP** (you will be notified in writing a minimum of 14 days before setup with the date and time)
- ARBA and breed club sanctions (must be applied for and received a minimum of sixty (60) before the show date)
- Provide and compensate judges for their entire bid. This includes but is not limited to judging fees, transportation to and from the showroom and airport, hotel accommodations, parking fees, meals, and travel expenses
- Hosting the show with show personal
- Show catalog
- Airport, parking fees, and transportation of exhibitors and animals to and from the showroom and airport.
- Feed and water cups

4. Additional terms that will be met by \_\_\_\_\_ (acronym)

- The total number of coops requested must be received in writing via email at [lauriebnorman@yahoo.com](mailto:lauriebnorman@yahoo.com) to Laurie Norman by 10:00 PM the Monday prior to the show.
- Show area **MUST** be kept cleaned and maintained including the paper towels used in the judging coops, food and beverage containers, and general garbage to be placed in the garbage cans provided (excluding shavings in coops)
- All rabbits must be removed from the coops by noon Eastern Time on Sunday of the show weekend.
- Any materials including but not limited to coop tags, feed and water cups, cardboard, and decorations must be removed from the coops by noon Eastern Time on Sunday of the show weekend



## 5. Additional Information

- National shows are limited to Saturday of the weekend specialty shows may be held on Sunday
- No animals are permitted in the showroom before noon Eastern Time on Friday of the convention weekend
- Club booth cost will be provided on the booth contracts. Booth space is 8'x10' that includes 1 table and 2 chairs. Side drapes or table covers will not be provided, and drape used must be flame retardant
- All rabbits entered in the national show must be cooped
- No other animals other than rabbits, covies, youth contest animals and service dogs will be permitted in the showroom
- Parking passes can be purchased at the gate. Contact the Ohio Expo Center for pricing
- Camping permits can be purchased at the gate with full-service electric, water, and sewage, subject to first come first serve. Contact the Ohio Expo Center for pricing
- Any payment paid to judge(s) by the sponsoring club will NOT be subtracted from monies owed to OSRBA, INC. \_\_\_\_\_ (acronym) hereby releases OSRBA, INC. its officers, directors and show committee from all rights, claims, and actions, which the \_\_\_\_\_ (acronym) and its successors now have or may have after signing this agreement. This agreement constitutes the entire agreement of the parties and supersedes all prior understanding, written, or oral agreement between parties respecting this subject matter.

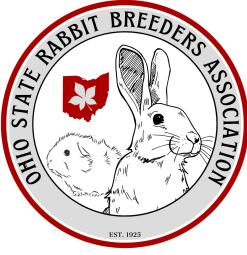
